

TERMS & CONDITIONS:

1. Once your booking has been submitted your booking is confirmed subject to payment and you will be sent a Tax Invoice to the email address entered. Tax Invoices are strictly payable in 14 days.
2. All memberships must be paid for prior to attending the academy training sessions & by the due date on the Tax Invoice, otherwise late fees apply.
3. A late fee of 5% will apply to all invoices that are not paid within the 14 day period.
4. All monthly payment options are liable to pay the membership fee for the period of the package selected when joining.
5. Cancellations made up to 14 days before the start of the membership date will receive a refund less a \$20 administration fee & \$30 Uniform fee. Cancellations made 7 days before the start of the membership date will receive a 50% refund less a \$30 Uniform fee. Cancellations within 7 days of the start of the membership will receive no refund. In the event of injury or illness (and on presentation of a medical certificate) you will be refunded your membership fee less a \$20 administration fee & \$30 Uniform fee. Substitutions are welcome as long as we are notified by email. If you choose to cancel your membership during your training program you will receive no refund, however we can suspend your membership as per section 9 below.
6. In the event of injury or illness (and on presentation of a medical certificate) you may suspend your membership immediately until further notice. You must notify us via email at basketball@corlettosports.com.au and provide us with a medical certificate.
7. You may choose to suspend your membership at anytime due to holidays, illness etc however you must provide us with one week written notice prior to your suspension and the minimum suspension is for 1 week. Your written notice must be sent to basketball@corlettosports.com.au (please specify in the email the dates you choose to suspend your membership and resume your membership)
